

### Terms and Conditions of “The Prosperity Reward”

1. The promotion period of The Prosperity Reward is from 1 January 2026 to 31 March 2026, both dates inclusive (“the Promotion Period of The Prosperity Reward”).
2. The entitlement to Gift(s) applicable to each Eligible Customer (as defined below) is determined by the corresponding premium requirement according to the table below. (the order of Gifts’ allocation is subject to the policy issue date of the Eligible Policy(ies)).

  - (ii) An applicant is allowed to apply for more than one policy of iTarget 3 Years Savings Insurance Plan (acceptance of application(s) would be subject to underwriting result and the aggregate of the total annualized premium of all policies under iTarget 3 Years Savings Insurance Plan for each insured, and the decision of BOC Life shall be final). The Total First Year Premium of all such policies must fulfill the corresponding Total First Year Premium requirement of the policy before discount (“Total First Year Premium” means the total First Year Premium before discount for all policies of iTarget 3 Years Savings Insurance Plan successfully issued to the same Policy Owner during the Promotion Period of The Prosperity Reward. “First Year Premium” is based on the “Initial Annual Premium” (applicable to annual or lump-sum prepayment) or “Initial Monthly Premium” x 12 (applicable to monthly payment) in the proposal, and does not include levy, pre-paid premium(s) (if applicable) and extra premium loading imposed due to health condition (if applicable)); AND
  - (iii) the application must be accepted by BOC Life; AND
