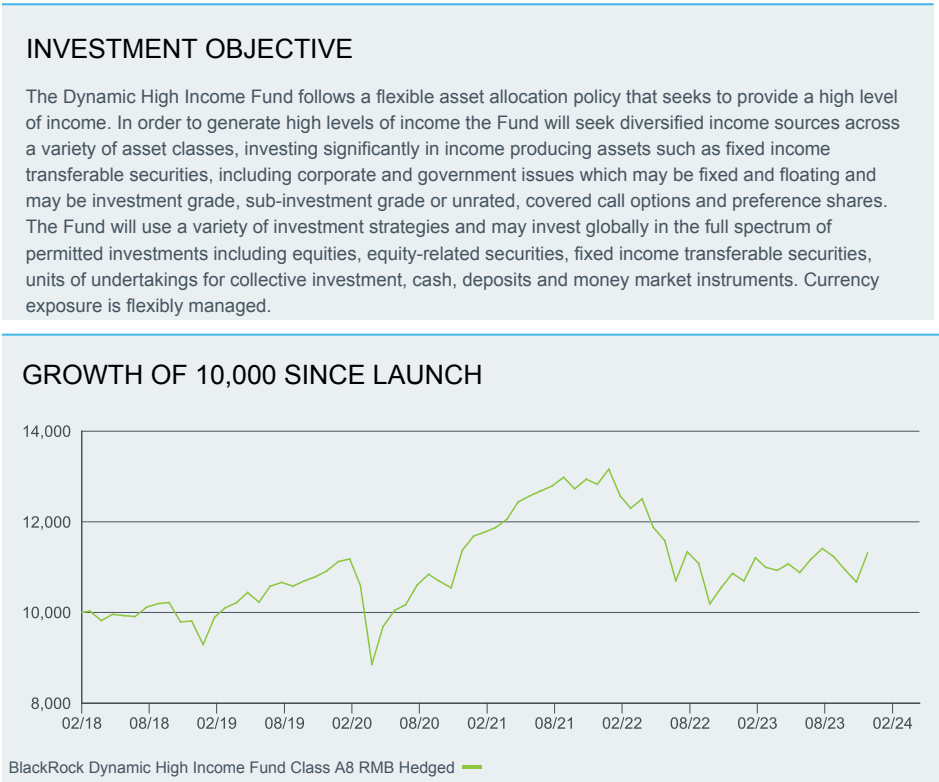

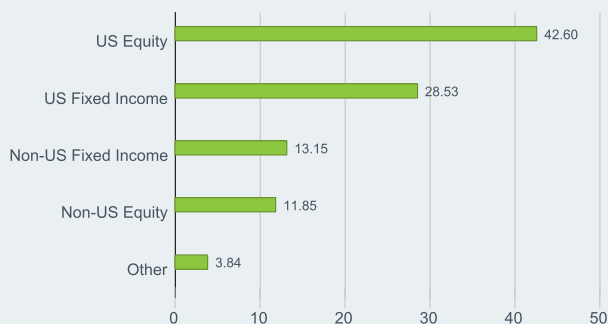

ASSET TYPE BREAKDOWN (%)



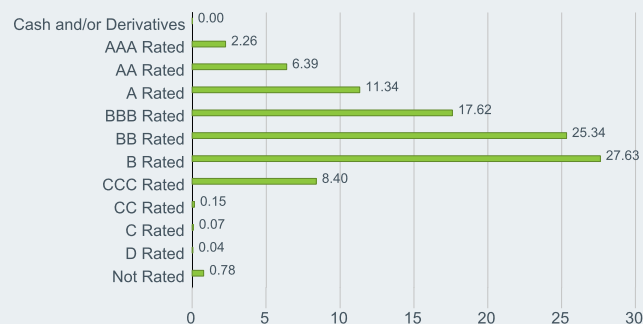

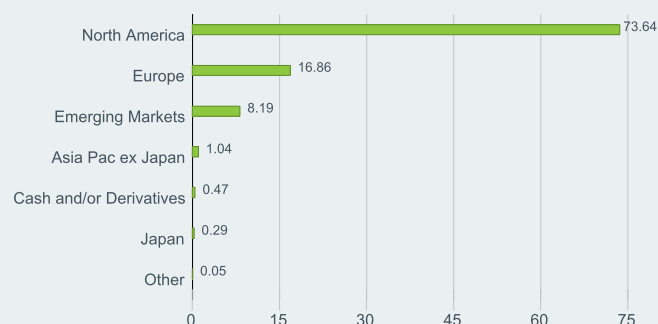
