FSSA Hong Kong Growth Fund

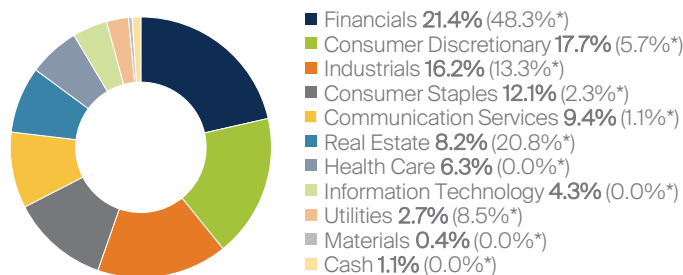

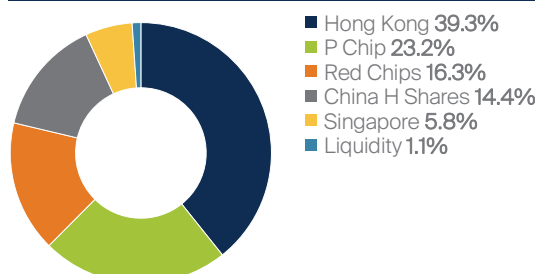
