## DELEGATED INVESTMENT MANAGER'S COMMENT<sup>^</sup>

- U.S. Treasury bond market slipped with yields climbing in June. Albeit keeping policy rate unchanged, the Federal Reserve (Fed) toned hawkish than expected at the June meeting, with the latest dot-plots pointing to roughly two more quarter-percentage-point hikes later in this year. Key inflation gauges, including CPI & PCE, pointed to persistent underlying price pressure, while other economic activity indicators stayed mixed. Futures market has now priced in a significant chance for a 25-basis-point hike to come in July, before rate pausing for the rest of this year. Repricing of rate-hike expectations prompted bond yields to rise, led by the front-end. Yield on the 2-year benchmark U.S. Treasury bond rose by 49 basis points to 4.90%, while that of the 10-year tenor increased by 19 basis points to end the month at 3.84%, bringing the spread between the two near the highest in this cycle.
- Global equities rose decisively and shrugged off a shallow pullback during the month. Growth stocks extended the rally as Artificial Intelligence frenzy continued. Risk-on sentiment was further supported by market optimism over an improving US-China relationship upon Blinken's China visit. Potential policy stimulus from China gave commodities stocks a boost.
- Soft landing narratives in the US and cooling price pressures helped offset concerns over the Fed's hawkishness and soft macro data from Europe and China. However, cyclical stock prices continued to face downward pressure on weaker global outlook and tighter credit conditions amid rising rates.
- During the month, US equities outperformed. Global fixed income declined slightly as government bond yields rose.
- In the near term, risks remain elevated around monetary policy tightening, geo-politics and growth uncertainty. As a result, volatility in markets will remain higher than normal.
