## DELEGATED INVESTMENT MANAGER'S COMMENT<sup>^</sup>

After a smooth start of year 2020 with the support of Phase I China-US trade agreement confirmed, market sentiment deteriorated on the emerging Coronavirus risk and its potential negative impact on global economic growth. US Treasury yield traded in tight range at the beginning of the month amid the expectation of better economic growth outlook. However, mixed US economic data releases capped the upside of US Treasury yield. The December US labor market missed market estimates that new jobs creation and wage growth both came in below expectation. Besides, the ISM manufacturing index remained below 50, signaling contraction in manufacturing activities. Later on, the Coronavirus outbreak led the market to turn to risk-off mode. The safe-haven flows drove global bonds higher. To fuel the rally further was the January FOMC statement, which signaled that the committee are not comfortable with inflation persistently below 2% target. In all, the 10-year bond yield dropped significantly by 41 bps on a month on month basis to 1.51% with yield curve flattened.

Global equities dropped in January. US stocks advanced to record high after the preliminary trade deal was signed off and companies' quarterly earnings beat investors' estimates. Concerns over the latest Coronavirus outbreak would likely reduce risk appetites. Stocks might continue to falter until the public health threat de-escalates. In the face of a heightened uncertainty, market volatility would prevail as investors shift focus to corporate earnings and fiscal support to look for a more sustainable growth driver.

The Fund posted a decline during the month. Equity investments in Asia Pacific ex Japan region including Hong Kong / China underperformed. Global fixed income recorded a gain as global government bond yields fell sharply. In the near term, we expect volatility in markets to remain elevated as Coronavirus outbreak, trade tensions and geopolitical concerns continue to drive investors' sentiment.
