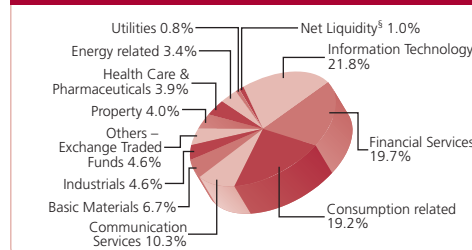

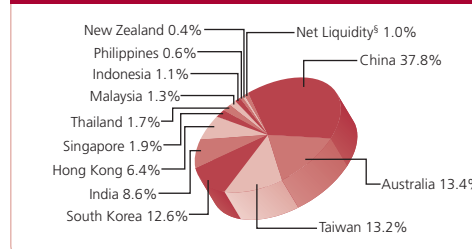

### INVESTMENT OBJECTIVES AND POLICIES

The BOCHK Asia Pacific Equity Fund seeks to achieve long-term capital growth by investing at least 70% of its non-cash assets in equities on the various stock markets in Asia Pacific. It is intended that the Sub-Fund will not invest in equities in Japan. The Sub-Fund may invest (a) up to 10% of its Net Asset Value in A shares (ii) directly through the Shanghai-Hong Kong Stock Connect and/or Shenzhen-Hong Kong Stock Connect; and/or (ii) indirectly through investment in exchange traded funds ("ETFs") listed on the Stock Exchange of Hong Kong Limited (including ETFs managed by the Manager) and/or SFC authorised collective investment schemes ("CISs") (including CISs managed by the Manager); and/or (b) up to 5% of its Net Asset Value in B shares listed on the stock exchanges in Mainland China. The Sub-Fund's aggregate exposure to A shares and B shares will not exceed 10% of its Net Asset Value. The Sub-Fund may also invest in other equity related securities such as ADRs (American depository receipts) and GDRs (global depository receipts) which may be listed on various stock exchanges.

### MANAGER'S COMMENT<sup>##</sup>

#### On Market

Economic data pointed to resilience of growth momentum in Asia. Reports on fourth quarter of 2020 GDP continued to surprise to the upside, reflecting a far more modest second wave drag than had been expected. As robust tech demand and a broader restocking upturn remain in place, the recovery in industrial activity continued apace. On the other hand, the growing chances of normalization on a global acceleration of Covid vaccinations and rising commodity prices led to a rise in bond yields amidst inflationary concerns. Against such macro backdrop, most regional central banks except Indonesia, which cut policy rate to boost growth recovery, stayed on hold. While there are financial stability risks to be watched, the uncertainty around growth trajectory makes it more likely fiscal and monetary policy settings will remain accommodative.

Asia equities extended last month's advance amid fluctuations. Stocks started the month on a firm note as concern receded over volatile retail trading and signs of an easing cash crunch in China aided sentiment. Risk appetite further revived amongst slowing global coronavirus infections and rising prospects for a robust federal spending package in the US. However, the rally faded into the month-end as investors weighed the implications of the recent jump in Treasury yields and the risk from higher inflation. Hong Kong's stamp-duty hike on stock trading also sparked a broad selloff in equities. Looking ahead, with equity markets continuing to trade at record highs, investors will be focusing on further progress of vaccination and re-opening, pace of economic momentum and continuity of policy support.

#### On Portfolio

The Sub-Fund registered a positive return and significantly outperformed the reference index mainly attributable to the under-weight position in China Consumer Discretionary (Consumption related) sector and over-weight position in China Basic Materials sector. The Sub-Fund would concentrate on both market and sector neutral strategy in order to achieve a more stable performance.

The value of the investment products managed by BOCI-Prudential Asset Management Limited represents 0.0% of the Sub-Fund's fund size.
