



INVESTMENT OBJECTIVES AND POLICIES

The BOCHK Asia Pacific Equity Fund seeks to achieve long-term capital growth by investing at least 70% of its non-cash assets in equities on the various stock markets in Asia Pacific. It is intended that the Sub-Fund will not invest in equities in Japan. The Sub-Fund may invest (a) up to 10% of its Net Asset Value in A shares ((i) directly through the Shanghai-Hong Kong Stock Connect and/or Shenzhen-Hong Kong Stock Connect; and/or (ii) indirectly through investment in exchange traded funds ("ETEs") listed on the Stock Exchange of Hong Kong Limited (including ETFs managed by the Manager) and/or SFC authorised collective investment schemes ("CISs") (including CISs managed by the Manager)); and/or (b) up to 5% of its Net Asset Value in B shares listed on the stock exchanges in Mainland China. The Sub-Fund's aggregate exposure to A shares and B shares will not exceed 10% of its Net Asset Value. The Sub-Fund may also invest in other equity related securities such as ADRs (American depository receipts) and GDRs (global depository receipts) which may be listed on various stock exchanges

MANAGER'S COMMENT##

- · Asia equities underwent a bumpy month and ended in loss.
- Markets got off to a positive start as investors weigh the potential end of the Fed's hiking path against the possibility of an economic slowdown.
- · However, investor confidence remained fragile as China's weaker-than-expected macro data showing initial reopening impulse fading.
- Equities have been stuck in narrow trading ranges, as the impasse in negotiations over raising US debt ceiling and worries about China's growth cast a shadow over markets.
- Successful stock selection in Communication Services sector added value while stock selection in Industrials sector dragged the Sub-Fund performance. The Sub-Fund would concentrate on both market and sector neutral strategy in order to achieve a more stable performance.

The value of the investment products managed by BOCI-Prudential Asset Management Limited represents 3.0% of the Sub-Fund's fund size.
